Dear Homeowner:

Included in this package is an application for our home repair and renovation services. <u>Before you begin filling out the application</u> please take a few minutes to read through the information below about our application and selection process so you can know what to expect over the coming months. Please note Rebuilding Together Dutchess County only serves owner-occupied homes in Dutchess County, and that the application process is a lengthy one. Should you apply, please understand that it may take a few months for you to hear from us and we ask that you have patience while we review the numerous applications we receive.

Application Period:

The application period for small repair services is year-round. The application period for large-scale repairs is from June 1, 2019 – September 30, 2019 for possible consideration for service in 2020. This is the time when we accept applications and verify homeowner qualifications. Rebuilding Together Dutchess County (RTDC) staff will review your repair application and determine if you are qualified for our services. Qualification means that you meet our income and home ownership requirements; this does not mean you have been selected to receive services. If you do not qualify, you will receive notification. If you do qualify, you will receive notification from a RTDC staff member.

Following qualification for large-scale repair services, you will be contacted by an RTDC staff member or volunteer who will schedule one or more appointments at your home to discuss the program with you and look at your home to determine what critical home repairs are needed to help ensure that you are able to live in a warm, safe, dry and independent home environment. Making your home warm, warm, safe, dry and independent are our main priorities. PLEASE NOTE: Having an RTDC staff member or volunteer visit your home does NOT mean that you have been selected for our programs.

Selection Period:

Unfortunately, not all homes can be selected. Our organization is funded through sponsorships and grants from the community and Rebuilding Together Dutchess County must base the number of homes completed on the funds available to us. Once all qualified homeowners have had their homes previewed and/or inspected, RTDC will review all of the applicants and select the homes to be repaired. For small-scale repair services, the selection period is year-round. Large-scale repair services will be determined to take place on the April and October service days in 2020, and these decisions are made by the end of February 2020. When and if an opportunity arises to have repairs completed at your home, an RTDC staff member will contact you to discuss this process and the anticipated timeframe as to when the work will be completed.

If you have any questions about the application process, feel free to call the office at the number below. Please make sure you read through the application instructions so that nothing is left out and your application can be processed as quickly as possible.

APPLICATION INSTRUCTIONS

Rebuilding Together Dutchess County Repair Services

Rebuilding Together Dutchess County offers both small and large-scale repair services. Please review the following information to determine the appropriate service for your repair needs and use the instructions below to help ensure your application is submitted completely and processed in a timely manner.

REPAIR SERVICES:

Small repair service - RTDC's small repair service provides timely small-scale repairs and safety and accessibility modifications. These repairs can typically be completed in four hours or less and include repairs such as grab bars, hand rails, improved lighting, minor accessibility modifications, and fire safety installations. *Please note that mobile homes are only eligible for fire safety installations.

Large-scale repair service - RTDC's large-scale repair service includes most critical repairs necessary to maintain a safe and healthy living environment, including, but not limited to:

- major accessibility modifications (ramps, stair lifts, bathroom, kitchen, hallway, etc.)
- plumbing, heating, cooling, and electrical system repairs
- stair, roof, porch and other critical structural repairs

ELIGIBILITY:

All applicants for Rebuilding Together Dutchess County Repair Programs must own and occupy a home located in Dutchess County, NY. Total gross income for the applicant household must not exceed:

Large-scale repair service ONLY: To qualify for large-scale repair services with Rebuilding Together Dutchess County, <u>all</u> of the following additional criteria must be met:

- Home value must not exceed \$275,000 (if you are unsure, RTDC can help verify this value)
- Mortgage (if applicable) and property/school taxes up to date
- Homeowner's insurance is up to date

Large-scale repair services: Please submit all application pages (Form A, Form B, and Applicant Agreement) alongside proof of total gross household income.
